MARJORIE KEDDY: A TRIBUTE

At its December 12th, 1991 meeting, **VALL** will be honouring one of its founding members and a pioneer in law librarianship in Vancouver, Marjorie Keddy. Many of our newer members may not be familiar with Marjorie's great contribution to the Vancouver law library community over a period of 38 years!

Marjorie originally hails from Edmonton. She began working in the Vancouver Courthouse Library in 1954. No doubt she had her work cut out for her there with a staff which consisted of herself and one assistant to serve approximately 1275 lawyers! Since 1884 the Secretary of the Law Society of B.C. has also been the Chief Librarian but as Alfred Watts in his <u>History of the Legal Profession in British Columbia</u>, 1869-1984 (p. 112) says:

Commencing, however, with the expansion of the library system in 1948 and the rapid introduction of new methods and new techniques of librarianship, it generally has not been possible for the Secretary qua Chief Librarian to be much more than a titular head of the library system, except in interpreting its financial needs as against other demands on the Society's coffers.

In the result, and commencing early in the expansion period of the 1950's, much of the burden was assumed by Miss Marjorie Keddy of the Vancouver library. This was recognized by the Benchers in 1969 in her appointment as assistant Chief Librarian. Library matters came a long way under her mentorship...

However, in 1973 Marjorie made a career move, leaving the Courthouse Library to test the waters of law firm librarianship as the hief Librarian at Ladner Downs. After seven hectic years there, Marjorie joined the freelance law librarian community, working at such firms as Shrum, Liddle & Hebenton; Harper, Grey; Ray, Connell & Company; Paine, Edmonds; and several others along the way! Last spring, Marjorie gave up the last of her clients to enjoy full-time retirement.

I first met Marjorie at my first Canadian Association of Law Libraries Annual Meeting in May 1974 in Winnipeg, at the closing banquet. The dinner speaker, an eminent local judge, continually put his foot in his mouth with sexist remarks to the point where Marjorie and I were rolling in the aisles with laughter and disbelief which we were unable to conceal from those around us, or from the speaker. After that evening we kept in touch - at the time I was the Chief Librarian at McCarthy & McCarthy in Toronto and had no inkling that five years later I would move to Vancouver and become a local colleague of Marjorie's. Over those first five years we commiserated with one another and consulted one another on various matters by letter or telephone; after I moved to Vancouver we collaborated on lectures to library school students on the joys and pitfalls of private law librarianship. Marjorie made this ex-Torontonian very welcome, giving me moral support and much needed advice and instruction on local and provincial law library matters and materials. Without this friendship and support, I would have had a much more difficult time adjusting to my new "home" and position as Chief Librarian at Russell & DuMoulin. Thank you for everything, Marjorie.

Marjorie helped many of us along the way; she was considered the "den mother" of private law librarians; she has always willingly shared her knowledge and expertise with her colleagues and for that we are all extremely grateful.

It seems fitting, therefore, that *VALL* will make Marjorie its first honorary Life Member. It is but a small token of our esteem, Marjorie. By making you a Life Member we are not only honouring your great contribution to our community but also ensuring that you do not leave us entirely. We hope to see you at many of our lunches in the future, if you are able to fit us into your busy "retirement." Best wishes for the future and thank you again for the legacy of your knowledge, professionalism, and friendship.

IN MEMORY OF PETER BARK

The VALL Executive chose to honour Peter Bark, a founding member of VALL and wonderful friend and colleague to many of the membership, with a lunch and speaker in his memory on November 14th, 1991. Tom Shorthouse, U.B.C. Law Librarian, addressed the membership with practical tips and notes on accessing the U.B.C. catalogue on-line. Peter would have approved of this nitty gritty current information being passed on to the membership. Astrid Kenning spoke in memory of Peter; her loving tribute follows.

On behalf of his friends and colleagues, I have been asked to say a few words in remembrance of Peter Bark, a long-time law librarian in this city, and one of the founding members of *VALL*. Peter's enthusiasm for the profession, his eagerness to meet with, and his willingness to share his knowledge with his colleagues was a major motivation in the establishment of *VALL*. Peter died a year ago this month after a lengthy illness.

For his many friends, Peter's passing left a big gap in their lives. Peter had a rare gift for friendship and the ability to make each of us feel special. He was enormous fun to be with: witty, charming, warm, self-deprecating, but never self-pitying. You could always count on him to raise your spirits on some gloomy day with a wickedly funny comment on events.

I was reminded of this attribute a year ago on the day of his memorial service - a service at which I was to have read a passage from the Bible, chosen by Peter (Matt. 6:25-34). The passage which contains the familiar words to "consider the lilies of the field..." which reminds us that life is brief, that exhorts us to have faith in God's eternal mercy, to eschew the things of this life, and lay up treasure in heaven.

On the evening of the service (a typical Vancouver November rain), I was rushing out of my house with Susan Daly who had arrived to pick me up. I slipped on the front porch steps, fell down hard, and broke my wrist. I didn't know it was broken at first, though the pain was gross, and I kept telling myself it would go away (which it didn't). With time getting short a decision had to be made. Susan left in one direction to fill in for me at the church; I went in the other, to the hospital, to get encased in plaster.

Sitting in U.B.C. Hospital's emergency ward, miserable, feeling badly that I had let Peter down, I could well imagine what his reaction would have been. I could imagine him sitting across from me, rolling his eyes, and saying "Any excuse to be late - and for MY funeral." And we both would have laughed hysterically.

Peter was very young when he died, only 35. But his was a life full of joy and sharing. He was interested in so many things, music particularly: he was a long time member of the Bach Choir and sang well; he played the piano and composed music. In the last couple of years of his life he began painting watercolours. He spent the last few months of his life painting watercolours as gifts for his friends - to be delivered to them after his death. I have mine still. Like Peter, it is full of joy and life.

He loved everything Latin - he spoke Spanish very well. He frequently went to Latin America on holiday, and was concerned for the poverty and oppression he found there. His concern translated into practical help and he and his partner, Rick, sponsored an immigrant family from Latin America. The family members were present at Peter's internment, and Rick continues to involve himself with them to this day.

Peter was a devout and practising Christian all his life. He had no fear of death, and no doubt that his soul would continue to live after his body ceased to function. But he also wanted to be remembered on this earth, certainly as long as his family and friends have memories.

Family - with all that meant, of closeness, love and continuity, was a passion with Peter. He had a keen interest in genealogy and made a hobby of tracing his ancestors. He wanted to be an ancestor himself, to have descendants.

Shortly before he became ill, Peter was close to realizing his great dream. He and his partner, Rick, had been approved as adoptive parents to a Latin American child. It was a bitter blow to him to come so close and suffer such disappointment. Nevertheless, he shouldered the disappointment in his characteristic way, and held ever closer to his family and friends.

I regret that child will not know the care and nurturing of this special person who had so much love to give. In lieu of descendants, it remains for us, his friends, to pay tribute to the memory of Peter Bark, to mourn his passing, and be grateful for the joy he gave in a life that was well spent.

Peter would be tickled pink that you came today to honour him. Thank you.

Canadian Legal Information Centre - INFOLEX PROJECT Cost Projection Study of Law Libraries

The deadline for the Infolex Project questionnaire and survey was November 20, 1991. The results will be tabulated and a report will be forthcoming early in 1992.

Report of the Canadian Abridgment Editorial Advisory Board

The Canadian Abridgment Editorial Advisory Board met in Scarborough on September 23, 1991 at the offices of Thomson Professional Publishing.

Canadian Law Online

Ulla de Stricker demonstrated a version of <u>Canadian Law Online</u> and summarized the scope and development of the project. The roduct will be introduced by Ulla to potential users during the .il months. At the time of the Board meeting pricing for the product had not been determined.

Index to Canadian Legal Literature

The Board requested that the <u>Index to Canadian Legal Literature</u> be made available as soon as possible on an online system other than Info Globe. At present, approximately 95 Canadian periodicals are indexed in <u>ICLL</u> and seven additional periodicals were recommended for inclusion by the Board.

Consolidated Table of Cases

The Board recommended that the next supplement to the <u>CTC</u> give an indication of dates covered on each page of the supplement and an explanation that using the <u>CTC</u> is a two step process.

Canadian Citations - Cases Judicially Considered (1870-1990) It was recommended that the citations be supplemented in the same manner as the <u>Case Law Digests</u>. Both the Board and editors have agreed that entries by defendant must be added to make <u>Canadian Citations</u> a one step research tool.

New Developments

<u>Canadian Law Online</u> was shown to people in Vancouver on November 13 and 14th. At that time it was suggested that the product would probably be released in the early part of 1992.

e Board will be meeting in Toronto November 22 and I will report any further developments which may result from that meeting to you in the New Year.

BIBLIO NOTES

Recent articles of interest from library and legal literature.

Foreign and domestic periodicals price index for Canada 1991: the first survey. By Colleen Bell, Karen Dicker, and Anne Marie Watson. In *Canadian Library Journal*, August 1991, Vol. 48, No. 4, pp. 255-261.

This is the first in what is intended to be an annual survey of periodicals for Canadian libraries. 5, 012 periodicals received in Canadian libraries were considered. They are divided into broad subject categories and the prices monitored for three years. 158 Law titles were included: the average subscription price per title for 1991 is \$137.97, a 4.2% increase over 1990. In 1990 the average price was \$132.23, a 10.7% increase from 1989. The average price for all periodicals for 1991 is \$248.14, up 11.9% from 1990.

Marketing the law firm library. By Nora Skrudrud. In <u>PLL</u> <u>Perspectives</u>, September/October 1991, Vol. 3, Iss. 1, pp. 1,6-7.

Your library and law firm: marketing for growth and survival. By Karin Donahue, Kevin Carey, and Rebecca Corliss. In <u>PLL Perspectives</u>, September/October 1991, Vol. 3, Iss. 1, pp. 13-14.

Two brief but useful articles discussing practical marketing ideas. They offer simple but effective suggestions which are feasible for librarians with little extra time (everyone, in other words), such as using consistent packaging for all information disseminated from the library. The second article defines the librarian's marketing roles as: literary agents, company analyst, industry analyst and forecaster, and sleuth. Nothing new there, but a reminder to librarians that we perform all those functions and our firms should be aware of this.

The Thomson Corporation: birth of a law book megapublisher. By Anna Belle Leiserson. In <u>The CRIV Sheet: Newsletter of the Committee on Relations with information vendors. AALL Newsletter.</u> November 1991, Vol. 23, No. 3, pp. 12-13.

Provides a brief history of the Thomson Corporation, followed by a discussion of the company structure and focusing on the Thomson Professional Publishing Group, which owns various law book companies. Recent world wide acquisitions of law publishers and the impact on the U.S. scene is discussed. Worth noting: Thomson Corporation is the highest ranked law book publisher in the Fortune 500 - the parent company is number 257 with 1990 sales of \$5.4 billion.

Write procedures that work. By Carol W. Cubberley. In *Library Journal*, September 15, 1991, Vol. 116, No. 15, pp. 42-45.

A straightforward primer directed specifically at library applications. Provides step-by-step directions creating effective procedures: gathering information, listing tools required, writing, addition of instructions and illustrations, testing and evaluating, revision, and knowing when to stop. Includes advice on use of illustration and typography, and has several examples.
