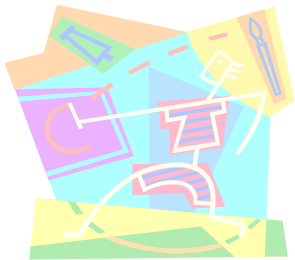

## FEATURE ARTICLES:

### Notes from “The Supreme Court of Canada Copyright Decision and its Implications” Session— CALL/ACBD Conference, May 16, 2004.

This session took the place of the traditional Vendors' Forum. The speakers were Ted Tjaden, Chair of the CALL Copyright Committee, Scott Jolliffe, from Gowling Lafleur Henderson LLP of Toronto, Counsel to the Law Society of Upper Canada and Glen Bloom, from Osler, Hoskin & Harcourt LLP of Ottawa, Counsel to the publishers. Karen MacLaurin, also a member of the Copyright Committee, moderated the session and provided a selected bibliography/webliography. (See pg. 4.)

As we entered the room we found on our seats a single sheet entitled “Are You Copying Fairly?” divided into two columns – “What you can do” and “What you can't do” with a footer at the bottom indicating that the sheet had been prepared for this session and expressed the views of CCH, Canada Law Book and Carswell. As the session proceeded it became apparent that the speakers were unaware of the distribution of this sheet and did not address its content.

Ted Tjaden opened with a comment on the case (“Fair Dealing Clarified: A Case Comment on the Supreme Court of Canada Decision in CCH Canadian v. Law Society of Upper Canada”) which can be found on the Copyright Committee's pages on the CALL website: <http://www.callacbd.ca/ip0a037e.html#1>

Ted also indicated that he wants to raise the profile of the Copyright Committee and expand the content on the Committee's pages on the website. He encourages any CALL member who wishes to join the Copyright Committee to speak to either him or Karen.

The next speaker was Scott Jolliffe who announced that he was speaking as a volunteer and not on behalf of the Law Society of Upper Canada. He spent considerable time summarizing the case and its history. Glen Bloom spoke next and began by saying that he was being paid by the publishers to speak at the session.

Both speakers indicated that their presentations will be posted on the CALL website and I would urge you to read them. At the time of writing, the presentations were not yet on the website. I presume they will be posted on the Copyright Committee's page.

In a nutshell, the speakers seemed to agree that the case had decided the following issues:



- Self-service copiers with warning sign not infringement
- Research was broadly defined
- Fair dealing was established as a right, not just a defense
- Great Library's copyright policy was important to the decision
- Headnotes, keywords and most secondary legal literature attract copyright
- Retaining copies to build a personal library an infringement
- Systematically copying decisions from a reporter an infringement
- The decision is applicable to private as well as "public" libraries

The issues around which the speakers had differing views were:

- Digital copies?
- Whole chapters?
- Multiple copies for routing?
- Copies of cases to keep in a file or give to a client?
- Access Copyright (previously CanCopy) licenses needed?

In short, the session was inconclusive and, at times, contentious. At the very beginning of the session Ted identified the challenge that we face is how to move forward. Karen wrapped up with, "I'm more confused than I was before this session".

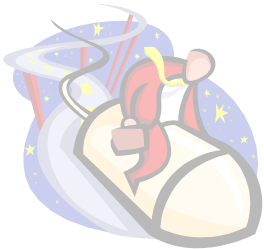

## Life in the Fast Lane for Information Professionals: A Summary

Carswell's HR Manager of Training and Development, Jayne Jackson, came out to Vancouver and gave a one day workshop for information professionals in April. Workshop goals were: to understand the nature of personal change, to explore our personal responses to change, and to develop a personal plan for strengthening one's ability to manage change. Class size was limited (13 attendees) and provided an environment conducive for sharing and group participation.

We discussed the seven dynamics of change and in particular, we looked at the change model by William Bridges. His theory is that change happens in three phases and that all phases must take place although the amount of time spent in each phase may differ. First phase is the ending of things as they were (with emotions range from denial to disenchantment), followed by the neutral zone where people are neither here or there, and then moving towards a new beginning (acceptance of new change). We all took turns sharing changes we were going through, either at work or personally, and indicated whether they were positive or negative changes and whether they were self-initiated or initiated by others.

Change doesn't just happen so if we are able to recognize the symptoms of stress, we are then able to do something about it. Stress symptoms included thought processes (such as lack of concentration, indecisiveness when making decisions), emotions (resentment, low morale etc.), actions (tardiness, haste and impulsiveness etc.), health (headaches, difficulty sleeping etc.), and relationships (poor communication, family abuse etc.).

One's ability to take in high levels of change while maximizing productive behaviour is one's resilience level. We did an exercise to discover our own baseline resilience, that is, the level of resilience we currently possess. We answered questions regarding how positive, organized, focused, flexible and proactive we were. These are the five basic characteristics of resilience. By charting these characteristics, we were able to see where we need to work to improve our resilience levels to better prepare ourselves for change.

We ended the day with a game aptly named "Chaos." Cards printed with bits of information were given out to the teams and the task was to try to answer a posed question by piecing together the larger picture. This involved much teamwork and problem solving skills and was a fun way to apply some of the skills we had learned.

It's difficult to summarize a whole day's workshop into mere words for this article. I found the class to be quite informative, applicable and would recommend taking it if the workshop is offered again!

### **Table of Local and Private B.C. Statutes**

In response to numerous requests, Vancouver reference staff has prepared a listing of all B.C. private and local acts and unconsolidated public acts. The table includes acts that are in force as well as those that are no longer in force together with amendments from 1872 to December 31, 2003. Here you will find listed statutes such as the Mosquito Control Act (a section allows you to substitute "gopher" for "mosquito" throughout the act!). The table also includes all of the acts incorporating municipalities, hospitals, religious institutions, railway and power companies and various other corporations as well as a complete listing of the amendments to the Municipalities Enabling and Validating Act, which was last consolidated in 1960.

The table is available in PDF on the BCCLS website under the LEGISLATION button on our home page. Please feel free to print out the table for use in your library.

### **B.C. Legal Literature Index**

*The Verdict* has just been added to the B.C. Legal Literature Index. *The Verdict* is published by the Trial Lawyers Association of B.C. and includes articles and biographical information on lawyers and judges. The index includes selected articles beginning with issue 16 in 1982 and is current to the latest issue received by the Vancouver Courthouse Library. The full text of all articles in *The Verdict* is available in the Vancouver Library.

We are also indexing the section papers of the Canadian Bar Association, B.C. Branch. Indexing is ongoing; we are up to 1998 and expect to be complete by the end of the summer.

### A RSS Service – Real Simple Syndication from Bloglines

Set yourself up with Bloglines ([www.bloglines.com](http://www.bloglines.com)) to manage library and news subscription services that have a rss feed (ie. tvc alert, llrx, lawlibtech, bespacific, etc).

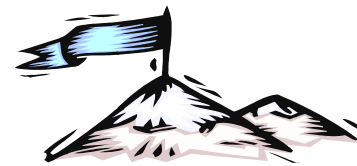
