Using Multilingual Dial-a-Law Scripts More Effectively

Dial-A-Law scripts are basic summaries of legal information concerning common legal questions and problems. The scripts are written for the general public in British Columbia. Dial-A-Law is a free service offered by the BC Chapter of the

Canadian Bar Association. The scripts are prepared by lawyers, but not meant as legal advice. They are great places to find basic legal information. The scripts can get anyone started in the right direction, before they pursue other avenues for information and advice.

There may be situations where a non-English speaking client needs your help, or is accompanied by friend or relative who acts as an interpreter, but who does not have perfect bilingual skills. The CBA of BC began multilingual translations of the scripts in 2004 to address non-English speaking users' needs. Now people who do not speak or read Chinese or Punjabi may still be in a position to help those who do by pointing to one or a few Dial-a-Law Scripts as a starting point. There are a variety of topics available in English, Chinese and Punjabi.

Each Dial-Law Script is numbered. Choose a Dial-Law-Script topic in English and note its script number. The corresponding translations will be:

- in Chinese, add a "5" to the beginning of the English Dial-Law Script topic number.
- in Punjabi, add a "6" to the beginning of the English Dial-a-Law Script topic number.

For example, the script: "Power of Attorney and Representation Agreements" is numbered 180 as shown here: http://www.cba.org/BC/Public_Media/dal/wills.aspx

Hence, on Chinese topic script would be 5180: http://www.cba.org/bc/pdf/dal/5180.pdf

and the Punjabi would be 6180: http://www.cba.org/bc/pdf/dal/6180.pdf

Some scripts can also be accessed through CBA of BC's automated phone system. The Dial-A-Law phone lines are available 24 hours a day, 7 days a week.

The B.C. Supreme Court Self-Help Information Centre

The BC Supreme Court Self-Help Information Centre (SHIC) opened in Vancouver on April 18, 2005. This is a one-year pilot project created in response to the perceived increase in the number of people representing themselves in court and their difficulty in accessing the justice system.

The SHIC will help unrepresented litigants get the information they need to prepare for their Supreme Court family or civil case. They will provide information on what clients should expect and what they may need to consider to get ready for court. The centre will assist them find and use appropriate resources, including self-help packages and forms. Litigants will also be referred to other agencies for further assistance, such as, to courthouse libraries for legal research and to free legal advice services as well as to alternatives to court. Clients can drop in Monday to Friday, 9:00am to 12:00pm, 1:30pm to 4:30pm at 274 – 800 Hornby Street, Vancouver.

With other partners from the justice and court system, BCCLS has participated in the development of this exciting and innovative initiative from the beginning. We have been involved in a number of the subcommittees that designed the services of the centre from the ground up. We also assisted with a publications audit of materials for the public and made recommendations for a basic resource collection for the centre. As an on-going member of the Steering committee and the Education sub-committee, we look forward to continue supporting the work of the centre and contributing on specific projects, such as developing research guides for the public.

From all reports, this service has been very well received and is seeing a steady stream of clients since they opened their doors. FEATURE ARTICLES:

BCLA Session - Pathfinders

This year the BC Libraries' Association annual conference was held in Burnaby. One of the sessions I attended was Laurie Prange's presentation on constructing Pathfinders.

Ms. Prange is a Reference/ Inter-Library Loans Librarian at Yukon College Library in Whitehorse. She has developed and refined general topic pathfinders for use in her small college library.

Laurie recommended the use of certain design elements to help the user find the information they need quickly and easily. Some of the simple, yet effective tips Laurie recommended are:

Use of tables, lists and bullets

Lists are easy to read, are concise, logically organized and easy to remember. More-so when offset in a box, columns, in colour or shaded.

Fonts, Bolding or Italics

Use different fonts to identify the relative importance words, phrases or concepts at a glance. Be consistent, but don't go overboard. Highlighting or bolding large areas of text is distracting and ineffective.

Graphics, Underlining or Outlining

The reader (especially those from the Internet generation) is better able to identify breaks in the information and follow the flow of text more easily if there are visual cues. Note: keep graphics simple for photocopying.

Colour

Use coloured paper to identify and isolate pathfinders from each other. Certain areas on your pathfinder may also benefit from being in colour if you have access to colour printers. Try a bankruptcy pathfinder on red sheets, and no one will forget!

Limit the amount of text

Try to stay away from filling your pathfinders with paragraphs of text. Limit to one introductory paragraph if you must.

White Space

The most essential, but seldom used design element. It is better to leave something out than to cram it in. The general rule is to have 1/3 of the page as white space. This allows the user to follow the flow and pick out the information they need quickly and easily.

Some other design elements I find useful are:

- **Consistency** Keep all of your pathfinders in a similar format, with notes, tips, further reading and contact information in the same order/ places.
- **Screen shots** It's often easier to include a cut and paste image of the "New Query" button in your database, rather than trying to describe the DBText-icon-with-the-page-and-the-Q-and-the-star-with-a-box-around-it.
- **Brand it!** Put your library logo on the pathfinder and format the same as you would for other research, memos, route lists or library stationary.
- **Contact information** Don't forget to include your contact information.

And finally, keep your pathfinders up-to-date, centrally and obviously located so they will be taken.



MEDICAL EXPERT EVIDENCE - An Annotated Bibliography

The use of expert evidence in litigation has increased dramatically in recent years. This has resulted in a steady stream of expert-related reference questions for the library.

Here are a few sample questions: How do I find an expert on sex change operations? Is there anyone in Canada who is an expert on Munchausen by Proxy? Has this expert's evidence been accepted by the courts? Do you keep expert evidence transcripts in the library? Can an orthopedic surgeon comment on the standard of care of a general practitioner? Do you have a copy of a ruling on admissibility of the expert's report by Dr. X?

In addition to general resources, creating an in-house expert database is a very useful library project. It is good to collect as much information as possible on a particular expert; cases they appeared in, rejections or acceptance of their evidence, lawyers' candid comments about an expert, rulings, and transcripts. These can all be immensely helpful when assessing an expert's suitability for a particular case, or when a lawyer is preparing to confront the opposing side's expert.

<u>NOTE</u>: This bibliography was adapted from a Harper Grey LLP in-house student seminar. It focuses on the resources we have in our library and highlights the use of medical experts, HG's forte. It is not exhaustive. (<u>BC Courthouse Library call numbers, where applicable, are included</u>).

HOW TO CHECK EXPERTS' TRACK RECORD

- □ Have the courts rejected or accepted the expert's evidence?
 - --Check case law on *Quicklaw*, *CLE Case Digests* or *Western Decisions (Dart)* Both CLE & Dart allow limiting the search to "expert evidence" making your search quick and easy. CLE Case Digest also notes whether the evidence was accepted, rejected, or just considered.
- □ Trial transcript collection of expert evidence.
 - --You can read the verbatim of the evidence at trial from trial transcripts.
- □ What has the expert published in the area of expertise? Is "the expert" truly an expert?
 - --Check library catalogues, leading journals of the expert's speciality and newsp aper articles. For medical experts check PubMed Medline (free) http://www.ncbi.nlm.nih.gov/entrez/query.fcg/
- □ Google
 - --Searches work too but check the authority of the site carefully.
- TrialSmith
 - --A US based organization serving plaintiffs' lawyers world-wide. They hold a large on-line collection of deposition transcripts and court testimony including expert depositions (both plaintiff and defendant). Subscription needed. http://www.trialsmith.com/databases.cfm
- □ CourtLink Lexis -US bases experts
 - --Allows searching filed court documents including motions to exclude testimony, resumes, reports, filed transcripts of testimony, affidavits, declarations etc.
- □ It is advisable to check the expert's record for disciplinary proceedings.
 - --Most licensing bodies (Colleges of doctors and other health professions, engineers, architects etc.) make this information available to the public, and it is often found on their web sites.
 - **If your potential expert has been disciplined, your lawyer does not want to hear about it from the opposing counsel in court!

Use the search boxes at the top of page to search for type of witness, and select "All Canada" or an individual province to search. Note, they do not actually give you the contact info on the Website--they just tell you if you get any hits in the database. You have to contact them to obtain the contacts (and probably pay \$\$\$). http://www.tasanet.com/

- 5) Identification of author, their official position title and parent organization.

- 6) No more than 3-4 resources of key value per issue. Title, edition, author and projected price is helpful
- 7) Of value, would be very recent new product developments that the vendor has not yet publicly released or the vendor would like feedback from its customers.

Note: If a vendor has already released public marketing information to all customers on its corporate web site, VALL Review editors will exercise rights to determine if there is sufficient space to include the submitted information, in light of other VALL content publishing priorities.
