## Improving our Communicating Skills by Doug Deane

Successful communicators do not blame others when difficulties arise; they accept the responsibility to adapt and change. By so doing, successful communicators acquire a higher level of competence in overcoming the challenges of understanding others *and* making themselves understood.

When misunderstandings arise, it is easiest to "react" to a "familiar" situation in a familiar way. But, this "reaction" is often defensive in nature. The urge to place blame on the other party often supercedes the desire to communicate effectively. Finger-pointing can be habit-forming because it absolves us from acknowledging that we might need to change. And, although comfortable at the time, taking the defence does not lead to resolution of the problem or to altering the surrounding environment that often fuels the problem. Finger-pointing leads to becoming a Non-Adaptor.

## Improving our Communicating Skills, *continued...*

Alternatively, those who succeed (Adaptors), acquire an enlightened understanding of the dynamics at play in communicating. This understanding provides an advantage; an invisible edge that enhances clearer communications. It also saves valuable time - while Non-Adaptors waste time allocating blame - Adaptors *invest* their time learning to win. Adaptors realize that no matter how foreign a problem appears to be at first, someone, somewhere, has learned to handle it, and Adaptors invest their time emulating skills that have proven to be successful.

This does not mean Adaptors stop at the first sign of success. They continue to learn from *every* encounter in preparation for those which will inevitably follow. Each new encounter is then met with increasing confidence, competence, and success.

And, communication challenges do tend to follow one another in a chain of expected occurrences. The successful communicator learns that presenting information, *without bias*, helps to break this chain. The Non-Adaptor, however, continues offering "advice" in order to reinforce their misperception that others seek help rather than information.

This leads us to another important communication skill - learning to "listen with" others. Listening with others is a catalyst to making a major adaptive transition. Non-Adaptors hear "just enough" to snap off a judgment; Adaptors wait to hear what's actually being communicated by listening between the spoken words.

Learning to give "unqualified acceptance" is another invaluable communicating tool. This skill is closely tied to listening with others but it focuses on avoiding the temptations of forming opinions, making evaluations, and offering self-serving comment.

Watching the behaviour of others for signs of upset is imperative to opening up the lines of communication. When people are upset, they tend to go "deaf." The Adaptor has the skill to read the situation in midstream and adjust. Meanwhile, the Non-Adaptor's advice and commentary is falling on deaf ears.

At our meeting on January 10th, we barely touched on all the "Do's" and "Easers" of communicating. Nor did we manage to get through the long list of "Don'ts." At first glance, this all seems like a lot to remember, *but do not lose heart!* Once the positive effects of the "Dos" and "Easers" are recognized, it becomes easier to use them than to avoid using them: a change in the "path of least effort" occurs. Remember, only opportunity and success await the Adaptor.

Ken Barnett has retired after 44 years of service with Carswell, recently reorganized as Thomson Professional Publishing Canada (TPPC). ## News Release from BCLA

National Library Convenes Resource Sharing Consultation in B.C.

Dr. Marianne Scott, National Librarian of Canada, met on February 5th with a number of key representatives of B.C. libraries to consult on the National Library's proposed national resource sharing strategy.

Discussion focused on the National Library's draft paper outlining phase one of the proposed strategy which addresses inter-library loan, information retrieval, file transfer access and management, enhancement of services and telecommunications capabilities.

Two provinces, British Columbia and Ontario, have been identified by the National Library of Canada as being in an advanced stage of network planning. For this reason, B.C. and Ontario have been selected to participate with the National Library in the initial stages of its coordinated resources sharing strategy and plan.

The consultation itself was a cooperative effort, chaired by the Library Services Branch of B.C.'s Ministry of Municipal Affairs, Recreation and Culture and hosted by the Open Learning Agency's Education Library Network. Other B.C. libraries represented were University of B.C., University of Victoria, Okanagan College, Vancouver Public Library, Fraser Valley Regional Library, school libraries, special libraries, and BCLA. Participants reported to Dr. Scott and to Carrol Lunau of the National Library Resource Sharing Strategy Team on the status of B.C.'s resource sharing initiative.

The group will re-convene at the BCLA's annual conference in April to continue to formulate strategies which will ensure that all British Columbians have equitable access to the informational resources of its major libraries.

## Second Run for "Mainstreaming"

SLA's popular 1990 Regional Continuing Education program, "Mainstreaming the Special Library" taught by Alice Sizer Warner, will take a second tour through the United States and Canada as part of the 1991 Regional CE Program. The first stop will be in Kansas City, March 8; followed by Minneapolia, May 10; Vancouver, May 17; Ann Arbor, October 25; New York, November 1; and Pittsburgh, November 8. The course will also be offered in conjunction with the 1991 Winter Education Conference in Washington, DC and the 82nd Annual Conference in San Antonio.

"Mainstreaming the Special Library" is a course not to be missed. Your colleagues who attended in 1990 consistently gave high evaluations for course content, relevance to their work, and instructor's presentation. Ms. Warner's strategy on positioning, money, and marketing are the key elements presented in the mainstreaming process. 

## **Communication Do's and Don'ts**

Doug Deane has kindly loaned us short-lists of the "Do's" and "Don'ts" referred to in his article on *Improving Communicating Skills*. Doug refers to Do's as "Easers" or "Greasing Techniques;" the Don'ts are techniques best avoided. The Don'ts are also known as "Prods," because people do not like to be *pushed* into participating. It is far more effective to "Grease" or "Ease" the lines of communication.

The following indicates the recommended "Easer" in the left column, versus the counter-productive "Prod" listed in the right column.
