REPORT ON THE CALL CONFERENCE

As the recipient of this year's Peter Bark Memorial Fund Bursary, I would like to thank **VALL** for enabling me to attend the **CALL** Conference in Winnipeg. This conference was the first one I have attended that was not held in Vancouver, so the experience was new to me. Winnipeg blessed us with warm spring weather, which only enhanced the charm of the city. The Conference was held at the Westin Hotel, located exactly at the famous intersection of Portage and Main, which is every bit as windy as its reputation had led me to expect.

The Conference was well-attended, with approximately 250 people registered, and a large group of exhibitors. The pre-conference workshop, held on Sunday, May 10th, was "Law Libraries in the Mainstream" with Alice Sizer Warner. Some useful and practical information about preparing budgets, marketing library services, and generally surviving in these days of economic restraint came out of the discussion groups in the afternoon. The following three days of the Conference offered Special Interest Group forums, the A.G.M., plenary sessions, and social events.

The plenary session on Monday featured Wendy Whitecloud of the Academic Support Programme, Faculty of Law, University of Manitoba, speaking on the role of the Academic Support Programme in encouraging Aboriginal Canadians to become lawyers and on issues particular to self-government. Professor Jack London, Faculty of Law, University of Manitoba, spoke on Aboriginal self-government and some financial aspects of Aboriginal land claims. It was definitely an interesting and timely presentation.

Tuesday, Professor Bill Graham, Faculty of Law, University of Toronto, spoke on the history and implications of the integration of the European Community. Following his speech, Debra Forman of the International Business & Trade Law Library, Bora Laskin Library, University of Toronto, gave a very useful outline of sources of materials that deal with the E.C.

We were treated to an opening reception on Sunday night. On Monday night there were tours of the new Royal Winnipeg Ballet building and a brief performance of a new piece by the company, followed by an evening at The Forks, Winnipeg's large indoor/outdoor market area. Tuesday night was Western Night and we all donned bandannas as we rode out of town on the Prairie Dog Central Steam Train for a barbecue and a fine evening of line dancing at the Hitchin' Post Ranch. The Vancouver contingent was well-represented by some of our more talented dancers.

The exhibits gave us all a chance to meet our sales representatives and to see whatever new offerings were available, as well as the chance to acquire lots of new pens. There were draws for various prizes on both Monday and Tuesday. I mention this only to announce that I was the winner of one of the two 9600 baud Hayes modems given away by QL.

The sessions were all interesting. I attended two Special Interest Group forums, both of which taught me useful facts and skills to take back to enhance my job. I also had the chance to meet many of the people I speak to regularly, as well as to meet many new contacts.

I would like to thank VALL and the donors to the Peter Bark Memorial Fund Bursary for giving me the opportunity to attend the Conference.

DID YOU KNOW?

Prior to 1988, all public, private, and local acts printed in the 1980-87 B.C. annual statutes appeared in the Table of Statutes, whether or not they were omnibus bills, and whether or not they had been amended or repealed.

From 1988 forward, although the description of the Table of Statutes states otherwise, omnibus bills are not listed in the Table of Statutes unless they have been amended or repealed.

Arlene Hartley, the editor of the Statutes of British Columbia has agreed to amend the description that precedes the Table of Statutes in the 1990 and subsequent bound statute volumes to specify that omnibus bills are not included if they have not been amended or repealed.

DINNER WITH MADGE AALTO

On April 23rd, 1992, VOLUG/SLA/VALL jointly hosted a dinner for their members at the Coast Plaza Stanley Park with Madge Aalto, Director of Vancouver Public Libraries, as guest speaker. The sixty-seven attendees were optimistically and humorously informed about the design competition and selection process as well as future plans and projects for the new Library Square.

Ms. Aalto outlined five years of work beginning with the City Referendum in 1990, working with the architects in 1991, breaking ground in 1992, and the move to the new building expected in 1995.

Twenty-eight firms originally responded to the design competition; these were pared down to eight. The key to this group was the pairing of outside firms with local architectural partners. Three firms were chosen with the unanimous support of City Council at each step along the way. The public was invited to participate by completing a questionnaire; over 7,000 took the time to complete the form with seventy percent choosing Proposal "C." One of the most interesting techniques used in the selection process was a tour of each of the three models with a miniature television camera, simulating a tour along Georgia Street, the plaza, and entering the library and discovering the friendliness and ease of access for each model.

Proposal "C" was the winning design awarded to Downs/Archambault & Partners of Vancouver and Moshe Safdie & Associates Inc. of Boston. The architects have a twelve week period to satisfy the City by conforming to the required specifications such as raising the library one floor, increasing the lighting standards, and increasing the floor space. Ms. Aalto has no doubt these conditions can be met.

Once established in the new building, Ms. Aalto suggested that circulation will double within eight to twelve months, reference queries will increase by forty percent and staffing needs will grow exponentially.

As the collections expand, compact shelving will be implemented and a special collection area will be developed for intrinsically valued collections. Audio visual materials will be concentrated in one area rather than in all divisions; similarly, periodicals and newspapers will be housed together with indices and reprography. A corporate services section will run a fee for service to the business and industry community. Taped or satellite transmissions of cultural events within the main library will be provided to other branches or to other parts of the province. Plans for technology will be the best possible for 1995.

Twelve million dollars is needed for capital expenditure over the next five years. Ms. Aalto would be grateful for any help we can give to the Library. Also, she would like input on what facilities we might like - such as a room with terminals and reprography to conduct our research

Ms. Aalto concluded with replying to queries from the floor covering seismic safety to cafeteria space to Sunday service.

B.C. Titles

New this year is the <u>B.C. Securities Act and Regulation 1992</u>. Similar in scope to the <u>Ontario Securities Act and Regulation</u>, this new Annual consolidates the Act, Regulation, Forms, Local and National Policy Statements, Uniform Policies, Blanket Orders and Rulings, and Notices and Interpretation Notes. A new B.C. edition, as well as an Alberta consolidation, will be out late this fall.

The second update to the <u>Annotated Insurance (Motor Vehicle) Act</u> was published in May. This release updates the case law to January 31st and brings the Act and Regulation current to April 1st. The fourth release to the <u>Annotated B.C. Company Act</u> was similarly sent out in April, updating the annotation to December 31st. The fifth release is schedule for publication in early fall.

National Titles

A number of new titles will be published in June. <u>The Law of Interest</u> by Mary Anne Waldron of the University of Victoria Faculty of Law, provides a complete review of the law relating to interest regulation and calculation, plus practical tips on drafting interest clauses.

Also due out in June is <u>Adult Guardianship Law in Canada</u> by Professors Rob Gordon and Simon Verdun-Jones of S.F.U.'s School of Criminology. This supplemented book covers the law and issues relating to adult guardianship and committeeship across Canada, including Quebec and the Territories. The authors have also prepared comparative tables of the legislation in all jurisdictions.

A number of new titles will also be appearing in <u>The Statutes of Canada Annotated</u> collection of bound annuals and biannuals. Purchasers of these annotations are kept abreast of legislative changes through pocket supplementation. Published to date are the <u>Annotated Labour Code</u>, <u>Evidence Act</u>, <u>Customs Act</u>, and <u>Competition Act</u>, along with the familiar annotations of the <u>Immigration Act</u>, <u>Tremeear's Criminal Code</u>, the <u>Bankruptcy Act</u>, <u>Indian Act</u> and <u>Unemployment Insurance Act</u>. The <u>Copyright Act</u> is due out within a few weeks. Expected later this summer and fall are the annotated <u>Citizenship</u>, <u>Bank</u>, and <u>Crown Liability and Proceedings Acts</u>, and new editions of the <u>Annotated Unemployment Insurance</u>, <u>Indian</u> and <u>Immigration Acts</u>.

Electronic Publishing

<u>Canadian Law Online</u> is now in general release. Users are reminded to check under "Announcements - Contents of the Database" when they log on, to keep abreast of developments in the database.

Electronic Publishing's Education Coordinator, Sam MacKenzie, will be in Vancouver in mid-July for a C.M.A. Conference. She will be available during that time to provide assistance to subscribers on both <u>Canadian Law Online</u> and <u>Canadian Tax Online</u>. A recent arrival at Electronic Publishing is Phil Faughnan, who is responsible for Sales, Electronic Information. Phil was previously with Infoglobe.

Canadian Abridgment

Revised Vols. R14B, R14C, and R14D of the second edition, containing the revised titles Environmental Law, Equity, Estates and Estoppel were published in March. Revised Vol. R14A, Employment Law, was published in April and updates and consolidates to the end of 1991, the material previously appearing under Master & Servant and Workers' Compensation.

As the Votes, Orders, and Bills are tabled in the Legislature they are immediately available for viewing and downloading into your system, twenty-four hours a day, on the *Queen's Printer Communications Network*. To gain access to this service requires a personal computer and a modem.

If you are interested in obtaining this new service, the *Queen's Printer* is offering a free two week trial period. After the trial period you may register as a full time user by sending in a *Queen's Printer* requisition or a purchase order. The cost for the service is \$100.00 per Legislative session.

Ouick Acts

Electronic versions of statutes and regulations are available from *Quickscribe Services* as a supplement to their popular looseleaf convenience legislation manuals. These include: Motor Vehicle, Municipal, Land Title, Insurance (Motor Vehicle), Family Relations, Securities, Motor Carrier, Commercial Transport, Industrial Relations, and Forest Acts. The statutes are often combined with some related regulations and have been produced in cooperation with *Guy Software* of Vancouver, developer of Racontex - a quick, search and retrieval program designed for large text databases. The *Quick Act* versions are set up for use with an IBM/PC or compatible XT, AT or PS2 with a hard disk. It is an excellent reference tool that can search specific words, phrases or sections of acts with quick, easy-to-use keywords and numbers. In addition, you can send whatever portion of text you select from your screen to your printer for hard copy output - even in Word Perfect!

Acts such as the <u>Motor Vehicle Act</u> is combined with Regulations 26/58 and a number of subscribers have found it ideal for searching two texts simultaneously.

Quickscribe Services plans to produce two updates a year for most of these products, at which time the entire disk is replaced for the subscribers. Costs for the Quick Acts range from \$50 to \$125. You may ask for a brochure detailing the pricing, etc. by contacting Quickscribe Services Ltd.

INFOLEX UPDATE

CLIC's INFOLEX project PHASE I - Cost Projections for Law Libraries in Canada - has been completed. The documents produced as a result of this project consist of the Main Report by Price Waterhouse, a Summary Report, INFOLEX Advisory Group Report, and Provincial Profiles: Canada's Law Library Resources 1991.

The Summary Report, the Advisory Group Report, and the Provincial Profiles will be published as a special issue of Canadian Law Libraries.

This study was perceived as a starting point for a series of studies looking at all aspects of law library expenditures, such as services, labour costs, and the role of technology. Since CLIC ceased to exist as of April 30, 1992, the continuation of the project was in serious jeopardy. At the Winnipeg CALL Conference, several resolutions were made asking for the membership's support for establishing some means for continuing these studies. All the resolutions were passed unanimously and CALL is now the custodian of the data gathered through the questionnaires. If possible, some of the data will be used in the future studies. Confidentiality of the respondents will be protected.

Here are some of the highlights of the Price Waterhouse cost projections for private law libraries:

Labour costs will increase by 4.0%, online charges by 13.1%, acquisition costs by 11.6%, and cost recovery will increase by 4.1%.

Recent items of interest from library and legal literature.

Forming and implementing a national information policy. By Brian Campbell. In *Canadian Library Journal*, February 1992, pp. 13-16.

In this opinion piece the author argues that librarians should be working to develop a policy to protect the right of free public access to information which is seriously threatened by the trend in treating information as a commodity to be bought and sold. He describes the success of the A.L.A. in criticizing U.S. government information policies and their effect on libraries. He calls on the C.L.A. Executive to provide similar political leadership in Canada.

Gateways: a snare and a delusion. By Judith M. Bird. In *Info* [Association des Bibliotheques de Droit de Montreal Association of Law Libraries Newsletter], April 1992, Vol. 3, No. 5, pp. 2-7.

As indicated by the title, the author describes the problems, hidden costs, and lack of complete access to various databases when using gateways such as CBANET and QL (for Westlaw) to access infrequently used databases such as newspapers and indexes. For

example, it is noted that Westlaw does not allow offline printing in Canada; and searching via CBANET means no online help and restricted searching flexibility when compared to subscription access to the same database.

A survey of the customer services available for a variety of online vendors. Provides a directory of the services for QL, CAN/OLE, DIALOG, etc. plus phone numbers and details on hours of availability. Includes tips for effective usage of help lines.

How to develop a marketing plan for a law firm library. By Kathy Shimpock-Vieweg. In *Law Library Journal*, Winter 1992, Vol. 84, No. 1, pp. 67-91.

The importance of marketing to the success of a law firm library cannot be ignored. This article outlines the steps necessary to develop a viable marketing plan, including conducting the situation analysis; setting objectives and goals; creating a marketing strategy; establishing a budget; obtaining management approval; and implementation of the plan. This practical guide is supplemented by a sample marketing plan and a bibliography.
