REVISED STATUTES OF BRITISH COLUMBIA: ELECTRONIC VERSION

Editors' note:

Jane Taylor has kindly allowed us to publish this article with the understanding that the following description conforms to their network and therefore not all the options on the FolioViews menu are discussed. The article was originally prepared for staff at the Ministry of the Attorney General.

1. GETTING STARTED

Choose the Statutes icon on your Windows screen. Use the **Tab** key to go down to the section of the database you want to access, (e.g. Full Text), then press **Enters**. Use the **Shift Tab** to go up the list. You can also use the **cursor** keys to move up and down the list. The **Esc key** will get you out of the database, in effect reversing the path you took to get to where you are.

2. CONTENTS

The electronic version of the Statutes includes all public statutes and amendments in force as of November 8, 1991, the Vancouver Charter and all third reading bills enacted during the previous session of the Legislature. Please read the Explanation of Infobase Contents for a complete explanation. Updates will roll forward in time, incorporating any previous third reading bills into the text of the statutes and providing the text of any third reading bills from the most recent session of the Legislature.

3. SEARCH TIPS AND TRICKS

Sign on to the <u>Full Text</u> section of the database. (See the section called **GETTING STARTED** for an explanation of how to get to <u>Full Text</u>.) The first page of the first statute will appear. Hit the **space bar** to bring up the search screen and type in a search term, such as cabinet. You will see that you get 6 matches. You will also see the word cabinet highlighted in the list of words. Another way to search is to cursor or page up and down the list of words and press Ctrl <Enter> to search that word. If you want to redo your search (too many hits, for example), backspace over the word (or hit Ctrl Home) and type in a different one.

There are ways to combine search terms to produce quite a sophisticated search:

And	A & B	A and B
Or	A/B	A or B
Not	A^B	A but not B
Phrase	"A B"	A B as a phrase
Proximity	"A B"@5	A within 5 words of B
Ordered proximity	"A B"5	A 5 or fewer words in front of B
Nesting	(A & B / (C & D)) ^ E	(A & B) or (C & D) but not E

It is also possible to use "wildcards" to truncate words, e.g. probat* for all words beginning in probat. The * can stand for any number of characters. You can also substitute a ? for a single character, e.g. station?ry to retrieve stationery or stationary. You can use as many question marks as you wish, each one representing a single character.

NOTE: Wildcards cannot be used in phrase or proximity searches.

Here is an example how to search for a specific section of an Act: "section 121 - municipal act" — the name of the Act must be accurate, and the spacing and quote marks must be exactly as in the example.

To limit your search to a single Act, go into the <u>Listing of Individual Acts</u>. Either bring up the Act directly from the listing, or do a quick word search to get to the right part of the listing (particularly useful if your Act is near the end of the alphabet). Then when you run your search, you will know that the results apply only to that Act.

4. VIEWING THE SEARCH RESULTS

Once you feel you have put together an effective search, you can look at the results by pressing <Enter>. The number of "hits" is noted in the top right hand corner. A "hit" is a section, also called a "Folio." The entire search result, i.e., all of the sections retrieved by your search, is called a "View." It is important to remember this distinction when using the electronic Statutes. Use the Tab key to go to the top of the next section, or page down through the sections, or press Ctrl G to go to a specific section. You can create a list of section numbers by pressing Ctrl T. You can then cursor down the list, and press <Enter> to view a particular section. Pressing the Esc key will

take you back to the list. While in the list, pressing Ctrl T will take you back to the full text display. Ctrl Pgdn will take you to the last hit and Ctrl Pgup will take you to the first.

5. PRINTING THE SEARCH RESULTS

While viewing your search results, you can print either a single section, the list of sections, the full text of a group of sections, entire Act or a portion of text which you have **blocked** (instructions below). Here's where the distinction between Folio and View becomes important.

Press Alt F to pull down the File Menu, then press P to print. You will be presented with three options. Make sure the cursor is beside "Print" and press <Enter>. This will take you to a screen-full of options. Move between sets of options with the Tab key. DO NOT press <Enter> until you reach the bottom of this screen. Use the cursor to choose either Folio, View or Blocked Text. Tab through the various sets of options. Now press <Enter>. When the "saving to disk, please wait" message disappears, your document will print. If it does not, hit the Esc key once.

Before printing the full text of a group of sections, press Ctrl R. This will attach citation information to each section you print. Otherwise you will end up with the text of a section and no clear reference to which Act it came from.

The following describes how to print an individual statute: from the <u>Table of Contents</u>, tab down to the <u>Listing of Individual Acts</u> and press <Enter>. Cursor or page down to the Act you want and press <Enter>. Press Alt F, then P. Cursor down to View on the Options Screen, tab through the option blocks, and press <Enter>.

6. BLOCKING TEXT

You may wish to block an area of text. Think of it as extended highlighting. It can be a few words, a few lines or even a few pages. You can print or create a file with the material that you have blocked. Place the cursor at the beginning of the material you want to block. Press Alt E to pull down the Edit Menu. Press B for blocking. Use the cursor keys to extend the block as far as you wish. Then press Alt F to pull down the File Menu, press P for print, and follow the directions for printing search results (above).

7. SIGNING OFF

Keep pressing the Esc key until you are back at the Windows screen.

8. HELP

There is a help facility which you can access by pressing the F1 key. There is also a small manual which comes with the system.

Re: Canadian Case Citations, 1867-1990

At a recent meeting of the Halifax Area Law Librarians (HALL), our organization was provided with a detailed explanation by Cyndi Murphy, Chair, Canadian Abridgement Editorial Advisory Board of the steps being taken by Carswell to rectify errors and omissions in the production of the Canadian Case Citations, 1867-1990.

Following Ms. Murphy's presentation, HALL resolved that a formal response be made regarding Carswell's plans to issue corrective supplements to Canadian Case Citations.

It is HALL's view that a preferred option would have been to reprint the product in its entirety at no cost to initial subscribers. Given the cost of this service, the reliance of academic law librarians on the Canadian Case Citations as a teaching tool, and Carswell's reputation among practising lawyers as a professional legal publisher, the re-issuing of a revised and corrected product is viewed as the appropriate option by HALL.

Many subscribers purchased this product primarily because of its promised completeness and single step research. Some law librarians who bought Canadian Case Citations after errors and omissions were identified by your editorial staff feel that Carswell has acted in bad faith.

HALL believes that subscribers should have been directly canvassed for their suggestions as to resolving the post-production problems identified both by Carswell and by users. However, given that the editorial decision has been made to issue a series of supplements, HALL is prepared to accept this option after noting our dissatisfaction with the shortcomings of Canadian Case Citations.

Finally, HALL strongly urges that in its future editorial plans, Carswell allow more time for consultation with its Editorial Advisory Board, and law librarian groups such as HALL, as to the design and content of major legal products such as Canadian Case Citations.

Thank you for this opportunity to present the views of the Halifax Area Law Librarians regarding the Canadian Case Citations, 1867-1990.

BIBLIO NOTES

Recentitems of interest from library and legal literature, summarized by Teresa Gleave.

Computer-assisted legal research in the real world: a primer for new attorneys and law clerks. In <u>PLL Perspectives</u>, April/May 1993, Vol. 4, Iss. 3, pp. 1, 4-6.

This is the text of a handout used by the author to train new lawyers and law clerks. Rationales and scenarios where computer searching may or may not be appropriate are briefly covered. Some of the major differences between LEXIS and WESTLAW are discussed, as well as strategies for minimizing costs in both systems.

Madonna, <u>Sex</u> and some B.C. libraries. By Lois Bewley. In <u>BCLA</u> <u>Reporter</u>, February 1993, Vol. 37, No. 1, pp. 25-29.

The BCLA Intellectual Freedom Committee surveyed eleven Lower Mainland and two Vancouver Island libraries for their collection policy on Madonna's controversial book. Seven libraries purchased a total of seventeen copies of which nine circulate and eight are considered reference and non-circulating. Six libraries did not purchase the book, citing reasons such as price and format, lack of reviews and/or interest, and failure to conform to the library's collection policy. Newspaper articles and editorials discussing the book and library and community responses are excerpted, giving a taste of the controversy generated by the book. This article provides a wonderful snapshot of some of the concerns and problems encountered by our colleagues serving the public library community.

<u>PERSPECTIVES Teaching legal research and writing</u>. Published quarterly by West Publishing Company.

This journal was introduced by West last year and "is intended to be a forum for all teachers of legal research and writing". It is not an advertising tool for the publisher and does not contain any other advertisements. A perusal of the first three issues yields many valuable articles for

those of us who use online services as well as teach others to use them. The spectrum is broad: plain language and gender-fair communication; how to write book reviews; educational theories such as analogization and cognitive theory; and innovative marketing techniques. Most of the articles are somewhat scholarly and often have extensive and valuable bibliographies. The publication is available free of charge from:

The results of the PLL-SIS survey of technical services functions in private law libraries, Part I. By Carol J. Dawe. In <u>PLL Perspectives</u> February/March 1993, Vol. 4, Iss. 2, pp. 10-14. Part II continued in April/May 1993, Vol. 4, Iss. 3, pp. 10-15.

The results of this survey provide valuable and infrequently collected information regarding technical operations in law firm libraries. The survey covers details such as number and qualification of staff and professionals; who shelves books and how often the shelves are read; the degree and kind of automated systems in use; filing backlogs; the presence of clipping services; how libraries interact with MIS departments; and much more. Using the data collected, technical services standards are proposed and will be elaborated upon in the future.
