STATUTES OF CANADA: FEEDBACK WANTED!

Suzan Hebditch, Librarian, Canada Department of Justice, Edmonton Regional Office e-mailed the following to multiple recipients of CALL-L and GOVINFO. The following is reproduced with her permission.

Tues. Aug. 22, 1995

Greetings all! I hope everyone is having a good summer.

I was contacted today by Mr. Robert (Bob) DuPerron, Chief Legislative Editor (Legislative editing office of the Canada Department of Justice). His office is involved in putting the Statutes of Canada together. He has asked that the following information go out to law librarians.

- 1. The rumour about the discontinuation of the looseleaf version of the Statutes of Canada is true. Instead of continuing the very dated looseleaf edition, Justice will be releasing the statutes in a CD-ROM format. The Canada Communications Group (CCG) is selling them. My understanding is that the first release is to come out next week (September 1) and will be current to April 30, 1995. The cost of the bilingual service is \$225.00 per release. Two releases per year are expected. (This information was included in a press release that Allan Rock, Minister of Justice released from Ottawa on August 20.)
 - I told Bob that I had yet to see anything out from CCG in writing about this, even in the pink lists. He said he would call them and encourage them to get the information out to the community.
- 2. Secondly, his office is expecting to have the regulations out in a CD-ROM version later in the year. (Also mentioned in Minister Rock's news released from Ottawa on August 20.)
- 3. Thirdly, Mr. DuPerron wants to keep the historical citations that appear in the margin notes in amending Acts in the CD-ROM version. (These notations lead the reader to the earlier iteration of the section and allow for ease of use when doing legislative histories, for example.) However, he is getting some opposition to keeping those notes. He would like to canvass librarians, practitioners and anyone using the Statutes regarding their opinion. Personally, I want to see the historical citations and I think it would be a real bonus to see such notations in the regulations.

Please let me know:

- a) Do you find these notes useful?
- b) Do you want them kept?

He is keen to put such historical citations into the CD-ROM version of the regulations.

- a) Do you think these notes would be useful?
- b) Would you like to see these added to the regulations?

This is one of the first times ever that I can recall the Department of Justice taking a proactive stance and consulting with users of the Statutes of Canada before making a decision to change something. Let us react in kind and provide some strong feedback.

I would like to have any and all responses by September 10 so I can get back to him.

Report from the Canadian Association of Law Libraries (CALL) Conference

VALL is pleased to bring the following submissions from various members who attended the CALL Conference held in Regina, Saskatchewan in May. The News Release was sent by CALL specifically to be included in VALL REVIEW.

Is CALL Relevant to Us?

The first time I was fortunate enough to attend a CALL Conference was in 1976 when it was held in Vancouver. It was my second year working in a law library and I was overwhelmed with the idea of becoming a member of a national organization called "The Canadian Association of Law Libraries", and being asked to assist with the local planning arrangements! I assumed that since it was a national organization, the conference wouldn't have much relevance to my very localized job. But, there weren't many of us working in law libraries in Vancouver then and it was essential for everyone to get involved.

You may be wondering what any of this has to do with the 1995 CALL Conference. For me it has everything to do with it because the benefits of belonging to CALL and attending the annual conference are just as relevant to my job today as they were when I first experienced them in 1976! I discovered the obvious, an organization is only as valuable and effective as the sum of its parts, ie. its members. The people who make up "CALL" are an impressive group who consistently demonstrate a high degree of dedication and provide a marvellous network for the benefit and support of every member. The benefits of meeting and exchanging ideas, concerns, problems and solutions with other members who

CALL Conference 1995

We enjoyed dinner at the Saskatchewan Centre of the Arts followed by a performance of the play "The Trial of Louis Riel". Canadian Association of Law Libraries Hold Annual Meeting

KINGSTON ONTARIO, July 17, 1995 — The Canadian Association of Law Libraries/Association Canadienne des Bibliotheques de Droit (CALL/ACBD) recently held their annual conference in Regina Saskatchewan. The theme of the conference was "Expand Your Horizons" and was highlighted by a session on Children's Rights to mark the global ratification of the Convention on the Rights of the Child and the 50th anniversary of the United Nations. The program also included a number of presentations for Special Interest Groups as well as a Pre-Conference Institute on how to develop, market and operate a fee-based service in a law library.

Overview of Folio INFOBASE Building Course

The Folio Infobase Building Course is one of the three training courses which is offered by the Folio corporation. The Infobase Building Course was held in Vancouver during August 16 - 18, 1995 and I highly recommend this course to anyone who has wondered about the differences in the Folio-based products which are becoming more and more commonplace in our organizations.

The Infobase Building Course is "hands-on" training and limited to 10 attendees. There were 8 attendees at the course held in Vancouver and all but two were from the United States. The companies they represented were a legal publisher, a computer chip manufacturer, a telephone company, a real estate management firm, and a Lower Mainland hospital. Most of these people had active projects with the Folio Views software for in-house policy and procedure manuals, training manuals, hospital records and legal materials. It seems that the Folio software is widely used for a number of applications.

The Folio Infobase Building Course involves taking unformatted ASCII text and creating an infobase using the VIEWS software. (The commercially produced Folio-based products are known as Bound VIEWS. The VIEWS is a special version of the Bound VIEWS which allows one to create new databases.) There is a brief overview of what levels, fields, groups, and links are and how to use them in creating an infobase. The creation and use of various paragraph and character styles are also explained. The utility programs that come with Folio VIEWS are also reviewed and some of the technical aspects covered include: the various codes used in creating infobases, how to import graphics into infobases, how to automate the infobase building process and how to implement security.

Although the three days were quite intensive, the course gives a very good overview of the features of the software and provides a working knowledge of how to structure a Folio database. I now have a better understanding of the Folio technology and the reasons for the "differences" in the Folio-based products that I use. Various commercial vendors of Folio-based products use different features of the software and some have taken more time to structure their infobases than others. For example, Canada Law Book in their latest update to the Canada Statutes Citator (Windows version), has taken the time to include a Query template which allows some customized searching.

RESULTS FROM THE JUNE 1995 ROUNDTABLE SURVEY - PART I S.E. Manchur

The feedback from the survey generated an interesting list of "Suggestions for Topics" that was useful in helping to plan VALL's programs. Please note that titles listed are those provided on the survey, and were not verified.

These results are not scientific! Twenty-four responses were retrieved. Some reflect individual responses while others reflect those of an entire table.

CD-ROM Products: 16 libraries are using them, 7 are not. One firm uses tax products but the library is not involved.

Examples: In addition to the well-known products such as Provincial and Federal Statutes, Martindale-Hubbell and Canadian Legal Directory, these are also used.

CCH Tax Library, CCN, Carswell Tax Partner, Couch on Insurance, International Tax Treaties Database, Larson's Workers' Compensation Law, Pro Phone, Silver Platter, Tax Find (Revenue Canada).

Speaker/Workshop Topic Suggestions:


