June Lunchtime Session

Please join VALL for our June Lunchtime Session, "Metro Vancouver Bylaw Research" with guest speaker Suzanne McBeath. This presentation will explain the process by which bylaws are created for each of Metro Vancouver's three legal entities: Metro Vancouver Regional District, Greater Vancouver Sewerage and Drainage District and Greater Vancouver Water District. There will be a discussion of bylaw structure including how to identify the base bylaw, as well as consolidations and amendments. Searching tips will be provided as well as information on locating historical bylaws.

Suzanne McBeath is the corporate librarian at Metro Vancouver, a federation of 21 municipalities, one Electoral Area and one Treaty First Nation that collaboratively plans for and delivers regional-scale services. Its core services are drinking water, wastewater treatment and solid waste management. Metro Vancouver also regulates air quality, plans for urban growth, manages a regional parks system and provides affordable housing. Prior to joining Metro Vancouver, Suzanne was a research librarian with McMillan LLP and a librarian with Teck Resources Limited.
