In this interactive presentation, Kayla Strong and Nathan Lapper review some of the most significant cases decided by the Supreme Court of Canada in 2017/2018 and ask the audience to guess which way the court went on some of the toughest decisions faced by our Supreme Court in the past year.

Kayla and Nathan both developed a significant interest in Supreme Court of Canada jurisprudence through their experience as judicial law clerks.
