 - Paid out Sarah Sutherland Peter Bark award, her event was later than other PB award
 - Renewals mailbox & Zoom account
 - Beth suggested another membership renewal reminder email & Lawbster post were also suggested
- **Programs** Alex Everitt, Kate LeBere, Chelsea Merkl, Stephanie Karnosh, Kathy Barry
 - VALL Survey Results
 - 34 responses to survey
 - Scheduling conflict biggest issue flagged for not attending a substantive event; substantive event at lunchtime should this be revisited?
 - Advertise Education fund for ticketed events to help those who are concerned about ticket cost
 - People like events at peoples firms and seeing their libraries
 - High number of respondents say their organization covers cost of VALL membership & events;
 - Use "Networking" rather than "Social" in describing event so cost will be covered by organizations
 - Drinking and events hosted at pubs or lounges, highlight options for non-alcoholic beverages; mocktails, etc.
 - Survey respondents are satisfied with balance of substantive and social events
 - Good suggestions on types of substantive topics people would like to see
 - Good response to VALL salary survey
 - o Discuss how we would do this so it's still anonymous
 - o Compared to TALL/CALL survey
 - How data is presented
 - Type of library not further by position
 - Data at law firm is the most secretive, pay transparency act, this could be a good time for the survey
 - June Social venue was expensive; only doing winter networking event and doing more casual events, Mahoney's was a good event, June event 2025 could be more casual event, looking at a new venue
 - Changeover meeting Alex to join programs for first half of year to get new programs team up to speed
